Payment Options for Property Tax

- Payment Types & Fees for online and phone payments We accept e-Checks, American Express, Discover, MasterCard and Visa credit/debit cards.
 - Payers may use any combination of credit cards/debit cards/e-Checks for property tax payment.
 - E-Checks are free. A non-refundable surcharge of 2.35% of the total payment (\$1.00 minimum) will be added to each credit card and debit card transaction.

• Special Inventory Tax (SIT)

- o SIT Annual Declarations, Monthly Statements and payments can be submitted online and by mail.
- The Dealer must file a Monthly Inventory Tax Statement and Declaration to the Harris County Tax Office and the Harris County Appraisal District.
 - Online SIT Portal
 - New Dealer Complete the <u>SIT Tax Dealer Form</u> and email this form to <u>SITDept@hctx.net</u> to receive your user ID information.
 - Your application form must contain the following information:
 - o Dealer number (P Number)
 - o Person of contact
 - o Email address to be associated with the user ID
 - o Phone number
 - By Mail
